It addresses the growing interest in survivor engagement within anti-trafficking circles and the need to prevent harm and re-traumatization. The training is particularly beneficial for individuals seeking to transition from treating survivors as beneficiaries to working with survivors as colleagues but have experienced barriers in accessing the fundamental knowledge and basic tools to do so. This is a good starting place for people who want to supervise survivors as consultants and interns.

#### What the course offers

Pre and post-course surveys to measure where individuals are in their knowledge regarding survivor engagement and inclusion.

Definition of survivor inclusion. Exploration of the significance of equitable survivor inclusion in the anti-slavery/trafficking sector.

**Baseline organizational** assessment for survivor inclusion within your organization.

Tools to comprehend the commitment of allyship in the anti-slavery/anti-trafficking

sector.

The basics of trauma literacy in relation to working with survivors. Some of those include:

- What is Trauma-Informed?
